Exhibitor /Sponsor Agreement

Any party who registers as an Exhibitor on a NYSFSMA Conference Form, upon payment of the applicable fee, consents to the following terms and conditions:

CODES/AGREEMENTS

Exhibitors hereby agree to be bound by the “Rules and Regulations” of the Conference. Exhibitor further agrees to adhere to and be bound by:

- All applicable fire, utility and building codes and regulations;
- The terms of all leases and agreements between NYSFSMA and the management or owners of said facilities; and
- The terms of any and all leases and agreements between NYSFSMA and any other party relating to the Conference.

SPACE ASSIGNMENTS

Booth preference will be given to the Main Social Event Sponsor and Level 2 Exhibitors. After that, booths are provided on a first come/first served basis. Conference updates and additional hotel details will be sent to registered exhibitors.

BOOTH SPECIFICATIONS

Booth size will be approximately 10 feet long by 6 feet wide. One 6-ft long table with skirting and two chairs will be provided.

EQUIPMENT

All equipment shall be provided by the Exhibitor. Electric power is limited. You must indicate if power is needed for the exhibit.

LIABILITY

This agreement shall not constitute a partnership, employer-employee relationship, joint venture or agency between NYSFSMA and Exhibitor. Exhibitor hereby agrees to and does indemnify, hold blameless and defend NYSFSMA from and against any and all liability, responsibility, claims, demands, loss, damage, cost or expense of any kind whatsoever (including but not limited to cost, interest, and attorney’s fees) which NYSFSMA may incur, suffer, or be subject to, pay or be required to pay, as a result of intentional or negligent act or omission by Exhibitor or any of its employees, servants, or agents prior, during, and subsequent to the period covered by this agreement and the Exhibitor’s presence at the Conference.

Exhibitor further agrees that NYSFSMA and their respective agents and employees and the facility shall not be responsible in any way for:

- Damage, loss or destruction of any property of Exhibitor; or
- Injury to Exhibitor or its representatives, agents, employees, licenses, or invitees.

Exhibitor shall have the right to cancel this agreement up to **April 1, 2023** by written notice to NYSFSMA. In the event of such cancellation, NYSFSMA shall refund in full any rental payment already made by the Exhibitor.

CONFERENCE CANCELLATION

In the event that the Conference is canceled due to any circumstances beyond the control of NYSFSMA, the obligations of the parties under this agreement shall be automatically terminated and all rental payments made under this lease shall be refunded to Exhibitor.
